### Engagement of Environment & Social Safeguard Specialist (Individual) under Fourth Primary Education Development Program (PEDP4)

#### 1. Background

Bangladesh, a country with its astonishing economic boom has cherished the golden jubilee of its independence. For a rapidly developing country like Bangladesh, it is utmost important to ensure holistic development of the children which includes both intellectual and emotional development in such a manner that they can uphold the nation from all aspect. The Fourth Primary Education Development Program (PEDP-4) is the continuation of Government's approach after PEDP3 in thriving the excellence of children through the fulfillment of several distinct milestones including construction of need-based infrastructures for sanitation and water supply. The program is supported by significant contributions from Government as well as Development Partners (DPs). Department of Public Health Engineering (DPHE) under Local Government Division (LGD) of Ministry of Local Government, Rural Development and Cooperatives (MLGRD&C) is involved in the capacity of implementation partner to provide the water supply and sanitation facilities in the primary schools of Bangladesh. As per MoU signed in between DPE and DPHE and as per revised DPP (RDPP) of PEDP-4, DPHE will install 20,000 new drinking water sources in the primary schools, conduct water quality testing of 65,000 water points, construct 58,000 new Wash Blocks in 29,000 primary schools, conduct major maintenance of 10,000 wash blocks constructed in PEDP3, install water supply and sanitation facilities in the DD, DPEO, UEO, URC, PTI offices in the project tenure (July/2018 to June/2025) with an aim to provide safe drinking water and sanitation services in the primary schools under PEDP-4. Considering the work volume and diversity of work it is necessary to engage an Environment & Social Safeguard Specialist to ensure that neither environment nor surrounding community is disturbed due to the construction of WASH facilities in the primary schools of Bangladesh.

#### 2. Scope of Work

The Environment & Social Safeguard specialist will be based in the office of the Focal Point, Primary Education Unit, DPHE, Dhaka. The consultant will provide technical support to the Focal Point, PEDP4, DPHE, Dhaka along with program consultants and officials for pursuing smooth implementation of Water Supply and Sanitation activities in the Primary Schools and DPE related offices under PEDP4. In addition, s/he will assist the Focal Point, PEDP4 in monitoring and supervision of construction related activities in light of MoPME approved revised Environmental Monitoring Framework (EMF) and Social Monitoring Framework (SMF) of PEDP4. The said Environment & Social Safeguard Specialist will prepare, finalize and submit semi-annual environmental and social safeguard report based on the real-time data captured during the construction work. S/he will attend

DPE-DPHE and/or, MoPME-DPHE meetings, collect construction status report from district and upazilla offices, collect water quality test report, collect package wise data on environmental & social safeguard in prescribed format. The specialist will also assist the Focal Point, PEDP4 with preparation of other reports, solving site related construction issues and monitoring and reviewing progress of the ongoing construction activities through frequent site visit under the overall guidance and supervision of the Focal Point, PEDP4.

#### 3. Detailed Tasks

The Environment & Social Safeguard Specialist will work under the guidance of the Focal Point, PEDP4.

Key tasks (but not limited to) of the specialist would be as follows:

- a) Supervising and providing technical supports for the construction of water supply and sanitation infrastructures of the Govt. Primary Schools and DPE related offices on the basis of approved infrastructure plan and planning guideline (IPG) and Environmental and Social Safeguard framework (EMF & SMF) approved by MoPME.
- b) Preparing and updating questionnaire and outcome based survey sheets for capturing real-time environmental and social safeguard data based on MoPME approved EMF and SMF.
- c) Monitoring and supervision of construction related activities in light of MoPME approved revised Environmental Monitoring Framework (EMF) and Social Monitoring Framework (SMF) of PEDP4.
- d) Verifying and summarizing the received primary schools wise environmental and social safeguard screening form through web based platform and prepare monthly report on environmental and social safeguard compliance.
- e) Prepare, finalize and submit semi-annual environmental and social safeguard report (EMR/SMR) based on real-time data captured during the construction work.
- f) Revise the submitted EMR/SMR in light of the comments of DPE officials and development partners.
- g) Ensure that the environmental and social safeguard protocol of Government and Development Partners are strictly adhered during the ongoing construction activities in the primary schools of Bangladesh.
- h) Resolve site specific environmental and social safeguard issues if any by frequent site visit.
- i) Monitor the existing grievance redressal system (GRS) of DPHE and actively work for addressing any subsequent grievance generated due to the implementation of wash block and water sources in the primary schools of Bangladesh.
- Assisting in verifying revised estimates submitted by Upazila/Zila Engineers (AE/SAE/EE) on the basis of approved design and actual work done.

- k) Liaison with LGED, DPE, Development Partners of the program and other relevant stakeholders for efficient information flow on infrastructure plan, master plan, layout plan and environmental and social safeguard before, during and after construction activities in the primary schools.
- l) Co-ordination with primary schools, DPE local offices, DPHE local offices and DPHE HQ.
- m) Providing technical support for analyzing and updating data in PEDP4 Web based Software (TIMS) and Mobile Application aligned with PEDP4 integrated systems development plan.
- Assisting in preparing the work schedule (Gantt Chart) for monitoring the implementation progress of the works.
- Providing support for overall capacity building of the DPHE Upazila officials on ensuring quality of construction.
- p) Undertaking any other activities relating to implementation of PEDP4 as assigned by the focal point, PEDP4 (DPHE Part).

#### 4. Output and Reporting Requirements

- a) Preparing and updating questionnaire and outcome based survey sheets for capturing real-time environmental and social safeguard data based on MoPME approved EMF and SMF.
